Camp Hours

Day Camp hours are 9:00am-2:00pm, Monday through Friday. Please be sure to check the weekly activity sheet (given out on Mondays) for activities for the week. Also offered is our Tree House Gang which is available from 8am – 9am and 2pm - 5pm. *(more information available on website)*

Registration for Day Camp

Day camp registration is available online at www.eastonrec.com.

All children MUST BE registered online by 12:00pm on the Friday before camp starts, NO EXCEPTIONS. Children not on Monday's roster will not be permitted to attend camp. (Please note with lower registration last summer we will have minimum staff this year and may have max counts for multiple weeks. We encourage all parents to register early to avoid getting shut out of camp.)

Drop Off and Pick Up

Morning drop off is between 8:55am-9:05am. **You must walk up to the drop off point (Baseball field fence) and sign your child in and out daily with their counselor.** During pick up and drop off, please be **VERY CAREFUL** when pulling in and out of camp. The area is congested during these times. **CAMPERS ARE NOT TO BE DROPPED OFF BEFORE 8:55!**

If someone other than a parent or guardian will be picking up your child, please notify the Camp Director and your child's counselor during AM drop off. Authorized pick-ups must bring a picture ID. If you are picking up your child early, be sure to sign your child out with their counselor.

Medication & Sunscreen

There are no medical forms needed to attend Sunshine Day Camp. However, campers needing inhalers or epi-pens need to submit a medical form signed by both parent and physician. Please be sure to take the time to educate your child's counselor on any special needs or allergies that he or she may have. No other medications will be administered by the staff. **Children should come to camp with sunscreen already applied. If your child requires additional sunscreen applications throughout the day please be sure to supply a can of "spray on" sunscreen labeled with your child's initials.**

Weather Information

Campers are certainly not afraid of a little rain! However, if severe weather is in the forecast, our activities may be moved to SSES (located at 515 Morehouse Road) room #139. An EMAIL will be sent out ASAP that morning if this change is taking place. Drop off and pick up will be at the Kindergarten hallway entrance, around the back of the building.



What to Bring to Camp

Campers who are not lunch bunch should bring their lunch, and be sure to have an icepack inside their lunch EVERYDAY.

Campers should come to camp daily in comfortable clothes (we do get messy!), sneakers with bug spray and sunscreen already applied. Campers with “Beach Time” 1st on their schedule can come to camp with their bathing suit already on. We recommend water shoes/flip flops, water bottle and a beach towel DAILY.

Please do not allow your child to bring anything of value to camp (i.e. cell phones, toys, etc.). We are not responsible for lost or stolen items. *Be sure all items brought to camp are labeled with your child's initials!*

Each camper will get one T-Shirt for the summer. T-shirts will be handed out on Monday of each session. We will be tie dying the T-shirts during the week and wearing them on Fridays. Please read your weekly letter.

Please label all items brought to camp with your child, including lunch box, towel, clothes, backpacks, etc.

This will help us to avoid an enormous lost and found pile at the end of the summer. If you are missing an item, please let us know so we can check the lost and found for you. Each Friday, the lost and found items will be on display. Please take a look! Sometimes you don't even realize that you've lost something until you see it.

CAMP RULES & EXPECTATIONS

Certain behaviors are not welcome at camp. If they arise, the camper will be responsible for his/her actions. Behavioral policy: The **first** time a child misbehaves, he/she will be issued a verbal warning, the **second** time, a written warning will be given to parents, and the **final** warning will result in dismissal from camp with no refund given.

Campers are expected to stay with their groups at all times. Campers need permission from counselors to leave the group for any reason, including bathroom, or leaving for the afternoon.
