## TEAC Volunteer / CIT Contract

**To be filled out by CIT and a parent/guardian:**

I understand that to serve as a Volunteer / Counselor in Training, I must do the following:

1. Always behave as a role model for campers (after school students), and not participate in any horseplay.
2. Refrain from using any foul language.
3. Follow all TEAC and town rules.
4. Follow all health and safety guidelines.
5. Do not use any type of electronic device during camp (after school) hours around the students. **This includes cell phones!**
6. Act in a safe and responsible manner with campers (students). Excessive physical contact with the campers (students) is not permitted.
7. Focus on interacting with and monitoring campers (students) rather than socializing with other volunteers/CITs.
8. CIT's need to understand that this is a responsibility, I am expected to participate and work for the week /session. Assist with monitoring campers (students), setting up and participating in crafts and activities, etc.
9. Tell a counselor or director if I am having any problems or have any questions.
10. Remember that serving as a volunteer / CIT is a privilege and the students look up to you.
11. Dress for art, outdoor activities including sneakers.
12. Bring a nut free snack and/or lunch daily.
13. Call TEAC as soon as possible at 203-393-5597 if I am going to be late.

We the parent/guardian and Volunteer / CIT have read the above statements as well as the information on the Easton Park and Rec website with the CIT/Volunteer program information. The Volunteer / CIT agrees to follow them to the best of their ability. To make camp and after school a safe and enjoyable experience for children, misbehavior of Volunteers / CITs will not be tolerated.
